

# TAYLOR ELEMENTARY



Reopening Guidelines as of July 31, 2020.  
Guidelines subject to change based on Health  
Department, CDC, and district recommendations.

---

## DROP-OFF AND PICK-UP

---

- ☐ Our students will be entering the school through grade-level assigned doors. A map will be provided in teacher presentations.
- ☐ All students will be wearing their masks when they enter the building.
- ☐ Students will wash with soap and water or use hand sanitizer each time they enter or exit their classroom.
- ☐ School will be dismissed in the same manner with children exiting the school through their designated doors. Parents may line up outside the building but will not be permitted in the building to walk their child to class.
- ☐ Doors will be propped open for morning arrival, recess, and end of day dismissal decreasing students touching door handle surfaces.

---

## RECESS

---

- ☐ Recess times have been adjusted, so there are fewer children on the playground at one time.
- ☐ Lunch recess will be 15 minutes after lunch.
- ☐ In addition to lunch recess students, will have a 20-minute recess (kindergarten 10-minute recess).
- ☐ Students will not need to wear their masks during recess if they are maintaining a six-foot distance from each other.

---

## LUNCH

---

- ☐ Lunchtime is scheduled for only one grade level at a time in the cafeteria. Fewer students will be seated at each table.
- ☐ There will no longer be salad bars or self-service. Most food will be prepackaged.
- ☐ Students will be asked to sit and eat their lunch for 15 minutes, as we have done in the past. They will be excused one row at a time to go outside.

- ☐ We will have two lunchroom supervisors and our custodian, disinfecting the tables and benches between grade levels.
- ☐ We encourage families to use disposable home lunch options (paper sacks) so that all the materials can be thrown away safely and reduce the items being touched.
- ☐ Students will be entering the lunchroom through one set of doors and exiting the lunchroom through another set of doors to keep our traffic flow pattern in one direction.

---

## **CLEANING**

---

- ☐ Frequent cleaning and disinfecting of high use surfaces, bathrooms, and playground equipment will happen throughout the day.
- ☐ Each night classrooms will be disinfected.

---

## **MASK**

---

- ☐ Mandatory mask-wearing is a consequence of the current health crises. According to the CDC, masks are considered the most effective tool to prevent the spread of COVID 19.
- ☐ As of now, masks and/or face shields are required for students and staff, along with any volunteers. Gentle reminders will be given throughout the day to keep masks on.
- ☐ If the Governor lifts the mandatory mask requirement in schools, we will make the appropriate changes to our practice.
- ☐ Exceptions to the mask mandate will be in place for medical and special education students. Please contact the school principal for specific details.

---

## **CLASSROOM**

---

- ☐ Classroom seating will be as far apart as possible.
- ☐ Students will not be facing each other.
- ☐ Teachers are creative and will do the best they can to set up a great learning environment.

---

## **VOLUNTEERS**

---

- ☐ Volunteers are still encouraged to help in the classrooms.
- ☐ A background check will not be required.
- ☐ Volunteers will be required to have their temperature taken and fill out a wellness form, prior to signing in and entering a classroom. A mask will always need to be worn.
- ☐ Volunteers will be asked to wash their hands with soap and water each time they enter/exit a classroom.

---

## COVID SCENARIOS

---

- ☐ If a student comes to school and presents with symptoms, the child will be sent to the health room and will wait for their parent to pick them up. An employee will escort younger students to the health room.
- ☐ We have set up a separate health room for students to wait safely in. The health room has separate bathrooms and a separate door for parents to enter/exit.
- ☐ If a student comes to school and presents with symptoms, the child will be sent to the health room and will wait for their parent to pick them up. An employee will escort younger students to the health room.
- ☐ We have set up a separate health area for student to wait safely in.
